**9. Contractor's Commitments and Responsibilities:**

- 9.1. upon accepting the Cargo for transportation, the Contractor must inform the Customer in writing of the estimated delivery time. If circumstances that may prevent the timely delivery of the transport vehicle(s) specified in the Order to the loading site and/or the safe delivery of the Cargo to the destination arise, as well as other circumstances that could affect the execution of the Order, the Contractor is obligated to notify the Customer immediately, but no later than within 2 (two) hours of becoming aware of such circumstances. The Contractor must take all possible measures to resolve these circumstances and coordinate with the Customer on a new planned arrival time for loading/unloading. If any signs of an attempt to tamper with or damage to the Cargo is observed, or in the event of an emergency (e.g., sudden braking, changing the driving direction, going off-road, a collision with another vehicle or an obstacle), the Contractor must immediately notify the Customer and, if necessary, report the incident to the local police to document the circumstances of the traffic incident or suspected criminal activity. If any damage to the Cargo occurs, the Contractor must report it by phone at \_\_\_\_\_ and by e-mail at \_\_\_\_\_.
10. By accepting the Order and starting the execution of Cargo transport operations, the Contractor confirms that they agree with the conditions of the Order. The Contractor must send a signed and company-stamped copy of this Order by e-mail to \_\_\_\_\_ on the same day the Order is received by e-mail. Failure to comply with this condition provides UAB Auteks the right to impose a EUR 50.00 fine or cancel the Cargo. If the carrier does not send the signed copy of the Order but accepts the Cargo and begins transporting it, the Order is considered confirmed, and all terms of the Order become effective.
11. The contractual obligations and responsibilities of the Contractor and the Customer applicable to this Order are set out in the main Cargo Transport Organization Contract.
